

2018 Fees and Refunds

Student Fees

Fees are calculated for each student independently based on a number of factors including course and unit selection, eligibility for government subsidised training, applications for RPL or credit transfer, previous fees paid and eligibility for concessions. Fees quoted are applicable for training services provided in the current calendar year – further fees will be payable for training services scheduled to continue into future calendar years. The student fees as published are subject to change given individual circumstances at enrolment.

Fee for Service

Fee for service (FFS) rates apply to those students who are not eligible for a government subsidised training place.

Payment of Fees – All courses

Clients with pre-agreed credit arrangements will be invoiced in accordance with those arrangements. In all other cases, payment is required at time of booking to confirm your enrolment. Total fees due prior to the commencement of training will not exceed \$1,500.00 for individual enrolments. Where total fees exceed \$1,500.00, fees will be payable in instalments. Each instalment will not exceed \$1,500.00 per individual. Discounts may apply for group bookings or experienced operators who meet certain criteria. All tuition fees for accredited training are GST free.

Government Subsidised Training (Victoria)

Training programs may be delivered with Commonwealth and Victorian Government funding. To be eligible for a government subsidised training place you must be an Australian or New Zealand citizen or a permanent resident of Australia; and if you are 20 years of age or older as at 1 January 2018, the qualification that you are seeking to undertake must be at a higher level than that already held. Individuals who are eligible for a government subsidised training place under the Skills First Program may commence a maximum of two government funded courses at the same level in their lifetime and may commence a maximum of two government subsidised courses in any one year and may only undertake two government subsidised courses at a time. Eligibility for a government subsidised training place under the Skills First Program will be assessed by Foresite Training during the enrolment process.

Concession Rates and Fee Waivers for Victorian Government Subsidised Training

Concession rates may be applicable for eligible government subsidised students who hold a current Commonwealth Health Care Card, Pensioner Concession Card or Veteran's Gold Card and who enrol in a Certificate IV level course or lower. Concession rates also apply to those eligible government subsidised students who self-identify as being of Aboriginal or Torres Strait Islander descent and enrol in a course at any level. Full fee waivers apply to eligible government subsidised students who are prisoners from the Judy Lazarus Transition Centre or who are young people on community based orders.

Fees for Credit Transfer and Recognition of Prior Learning

Foresite Training does not charge any fees for Credit Transfer. The following indicative fees apply for Recognition of Prior Learning:

For students who are eligible for VTG funding - \$400 per unit

For students who are not eligible for VTG funding - \$450 per unit

If criteria are NOT met, including passing the knowledge test, students will not be able to undergo the on-road test and will continue to train for the duration of the course. Additional costs will apply if students book subsequent training and/or testing.

2018 Fees and Refunds

Refunds and Cancellations

Certificate/Qualification Enrolments

In the event of withdrawal from a non-government subsidised qualification, Foresite will apply a full refund, less an administration fee of \$250 if the withdrawal occurs prior to the commencement date of training.

In the event of withdrawal from a non-government subsidised qualification, Foresite will apply a refund of up to 50% of the total course fee (providing fees have been paid) if the withdrawal is before the half way point of the course, less any other costs or charges incurred by Foresite. Foresite will not provide a refund if withdrawal is after the half-way point of the course or at any time if the withdrawal was due to a student's removal due to unacceptable behaviour, absence or drug/alcohol intoxication.

In the event of withdrawal from a government subsidised qualification, Foresite will apply a full refund, less an administration fee of \$250 if the withdrawal occurs prior to the commencement date of training.

In the event of withdrawal from a government subsidised qualification, Foresite will apply a refund of up to 50% of the total course fee (providing fees have been paid), less an administration fee of \$250 and any other additional costs incurred by Foresite, if the withdrawal is before the half way point of the course. Foresite will not provide a refund if withdrawal is after the half-way point of the course or at any time if the withdrawal was due to a student's removal due to unacceptable behaviour, absence or drug/alcohol intoxication.

Non-Qualification Courses (Warehouse and Earthmoving Units, Worksafe High Risk Work Licensing and Other Short Courses)

A full refund will be applied if seven business days' notice is provided prior to cancellation. A partial refund of 50% of the total course fee will be applied if more than four business days' notice is provided. Cancellation within four business days or failure to attend will incur forfeiture of full payment with no refund applicable. Alterations to booking dates or transfers to a different course cannot be made within four business days of the course commencement date.

Driving Courses/Heavy Vehicle Licencing

A full refund will be applied if seven or more business days' notice is provided. Cancellation within seven business days or failure to attend will incur forfeiture of full payment. Alterations to booking dates or transfers to a different course cannot be made within seven business days of the course commencement date.

All Courses

Failure to attend will incur forfeiture of full payment.
